General Liability/Public Liability Insurance of at least \$1,000,000

Covers unintentional damage to the property of a third party where you are liable. For example:

- Costs to rectify damage by you or your employees to a client's premises while undertaking your professional services, such as installing or servicing security equipment.

Professional Indemnity Insurance from \$500,000

Covers your legal liability to compensate third parties should you be held accountable in a legal dispute. For example:

- Payment of legal defence costs and expenses for losses caused by negligence in the performance of your professional services.

Management Liability Insurance

Covers legal costs and expenses incurred in defending a claim of wrongful management of the company or its employees. For example:

- An unintentional breach of a New Zealand statute e.g. Privacy Act, Fair Trading Act.
- An employee dispute claim resulting from allegations such as wrongful dismissal, discrimination or sexual harassment.
